Product description:

Dalapro Roll Hydro is a blue ready-mixed filler for roller application in wet rooms or where an extra-durable surface is desired on all common types of indoor wall and ceiling surfaces. A high binder content in the filler gives the product a hard, water-repellent surface, and maximum adhesion to the substrate. The smooth consistency means that the filler can be spread evenly over the entire surface without effort.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:


